ARTICLES OF ORGANIZATION Laub, L.L.C.

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the STATE laws of the State of Florida.

ARTICLE L NAME

The name of the Limited Liability Company ("Company") shall be Laub, L.L.C.
