**ARTICLES OF ORGANIZATION OF  
SALZEDO TRUST LLC**

The undersigned, desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company act, hereby establishes the following:

**ARTICLE I - NAME**

The name of the company is Salzedo Trust LLC (the "Company").

**ARTICLE II - DURATION**

The remaining Members of the Company shall have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or occurrence of any other event which terminates the continued Membership of a Member in this Company. 
