Articles of OrganizationofE & E, LLCA Florida Limited Liability Company

1. Name. The name of this limited liability company is E & E, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

4. Place of Business. The street address of the Company's principal office is 263 Bigelow Street, Aranas Pass, Texas 78336 and its mailing address is P.O. Box 1003, Aranas Pass, Texas 78335.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Grant Erickson. The street address of the initial registered agent of the Company is 1100 Shrimp Boat Lane, Fort Myers Beach, Florida 33931.


6. Management of the Company. The Company shall be managed by a manager or managers and is, therefore, a manager-managed company.

8. Voting. The Company is authorized to issue membership units with voting rights and membership units without voting rights.

9. Certificated Interests. The members' interests in the Company may be evidenced by certificates.
