**ARTICLES OF ORGANIZATION
FOR
CLIPPING COUPONS ONLINE, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be Clipping Coupons Online, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 5230 North Orange Blossom Trail, #106, Orlando, Florida 32810.


