ARTICLES OF ORGANIZATION OF THERAPEUTIC ONCOLOGY PHYSICS, LLC A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I NAME

The name of this Limited Liability Company shall be **THERAPEUTIC ONCOLOGY PHYSICS**, **LLC** and its principal place of business shall be located at 2630 Park Royal Drive, Windermere, Florida 34786.
