ARTICLES OF ORGANIZATION  
FOR

The undersigned, acting as organizer of CATMED, II, LLC, under Chapter 608, Florida Statutes, adopts the following Articles of Organization.

ARTICLE I. NAME

The name of the limited liability company (the "Company") is:




