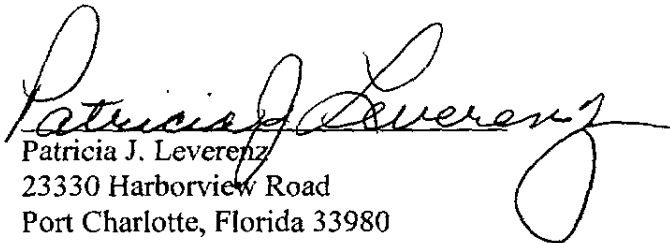

OF

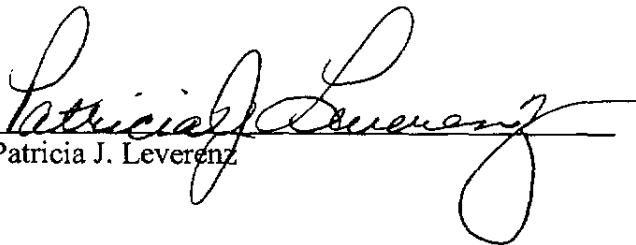

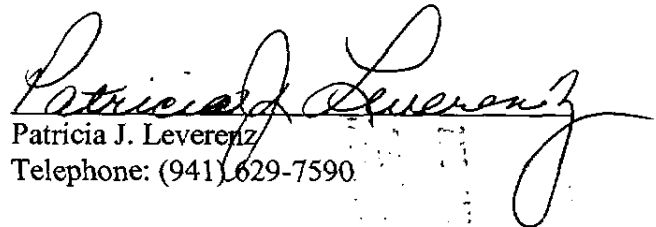
