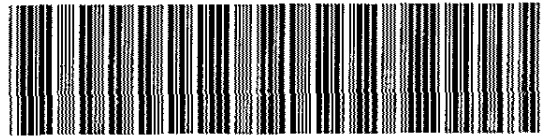


**ARTICLE VII


