These Articles of Amendment are filed pursuant to Florida Statute Section 608.411, to reflect amendments to the Articles of Organization of COLUMBIA HEALTH VENTURES, LLC, a Florida limited liability company (the "Company"), and in connection therewith, the undersigned member, hereby sets forth as follows:

1. The Articles of Organization of the Company were filed on January 10, 2005 and assigned document number L05000002685.

2. The Articles of Organization of the Company are hereby amended by deleting the following sentence contained in paragraph 8(b) of the Articles of Organization:

"All rights of members of this limited liability company shall be in proportion to their contributions to the capital of the limited liability company, as adjusted from time to time to properly reflect any additional contributions or withdrawals by the members."

3. The Articles of Organization of the Company are hereby amended by deleting paragraph 9 of the Articles of Organization in its entirety, and substituting in lieu thereof, the following paragraph:

"9. In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the business of the limited liability company may be continued upon the approval of the remaining members owning at least a majority of the percentage interests in the limited liability company (excluding the percentage interest of the affected member) to such continuance of business."

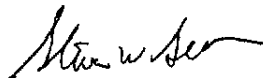
4. The Articles of Organization of the Company are hereby amended by deleting paragraph 14 of the Articles of Organization in its entirety.

5. In accordance with the Operating Agreement of the Company then in effect, the referred to amendments were adopted by the Board of Managers of the Company on March 31, 2005, and unanimous written consent to the said amendments was given on March 31, 2005 by the holders of one hundred percent (100%) of the percentage interests of the Company entitled to vote thereon. The number of votes cast for the amendments by the members of the Company is sufficient for approval of the amendments.

6. Upon the filing of these Articles of Amendment by the Department of State, the above referred to amendments shall become effective and the Articles of Organization of the Company shall be deemed to be amended accordingly.
