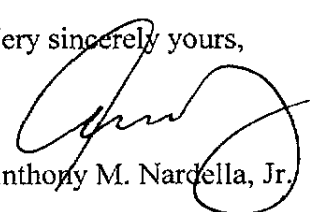

ARTICLE VIII — Limited Liability of Members and Managers

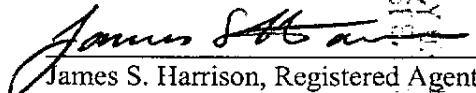
