ARTICLES OF ORGANIZATION OF NORTH JAX GROUP, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be NORTH JAX GROUP, LLC.
