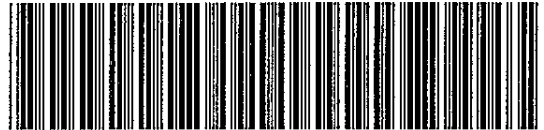

The undersigned, desiring to form a professional limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be Joseph R. Michalak, LLC.

2. Duration/Continuation. 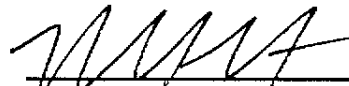
