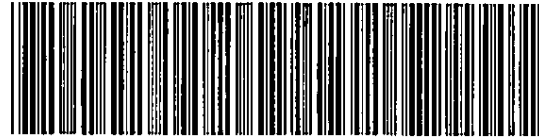

The foregoing amendment to the articles of organization was duly adopted by the sole member and manager of the Company.


