**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company for profit under the laws of Florida, adopts the following Articles of Organization:

**Article I  
Name**

**Section 1.1. Name.** The name of this limited liability company shall be Strickland Candy, LLC.

**Article II  
Principal Office and Mailing Address**

**Section 2.1. Principal Office and Mailing Address.** The principal office address of this limited liability company shall be 216 Redfish Creek Drive, St. Augustine, FL 32095 and the mailing address is 216 Redfish Creek Drive, St. Augustine, FL 32095.

**Article III  
Initial Registered Agent and Address**

**Operating Agreement**

**Section 9.1. Operating Agreement.** The initial Operating Agreement of this limited liability company shall be adopted by the members. The Operating Agreement shall be adopted, altered, amended or repealed from time to time as provided in the Operating Agreement.

**Article X**  
**Amendment**

**Section 10.1. Amendment.** The members, by vote of members holding a majority of the interests in the limited liability company, shall have the right to amend or repeal any provision contained in these Articles of Organization; provided, however, that it shall require a vote of members holding fifty-one percent (51%) or more of the interests in the limited liability company to amend or repeal Article VIII regarding merger.
