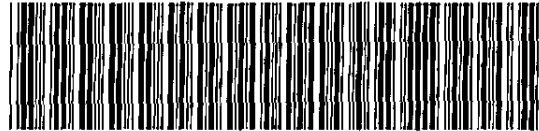

ARTICLE III: REGISTERED AGENT




ARTICLE IV: MANAGEMENT OF THE COMPANY

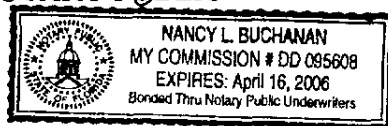

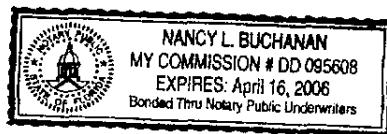


