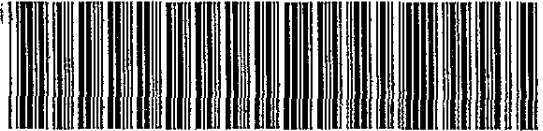


Article VII: Admission of New Members (Transferability of Ownership)
