HEIGHTS DEVELOPMENT LLC**

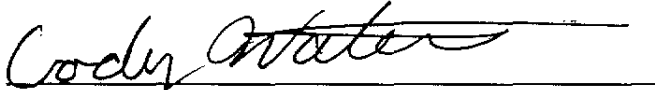
