## **ARTICLES OF ORGANIZATION**

OF

### ELYCIA, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### <u>ARTICLE 1 - NAME</u>

The name of the limited liability company shall be ELYCIA, LLC, ("Company").

#### **ARTICLE 2 - ADDRESS**

#### ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT


