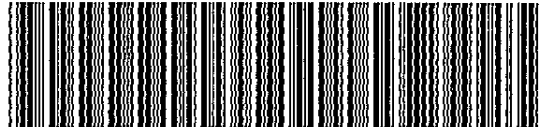



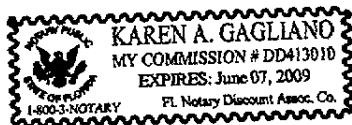
1. The name of the limited liability company is KITCHEN PARTNERS USA, LLC.

6. There are no suits pending against the limited liability company in any court.


