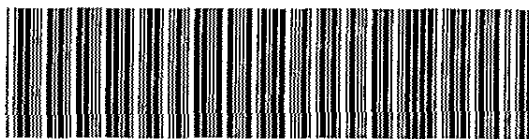




Resolution to Revoke Membership in L.L.C.
