ARTICLES OF ORGANIZATION OF IDC, LLC

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") shall be IDC, LLC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

ARTICLE VII. MANAGEMENT

The Company is to be managed by one or more managers and is, therefore, a managermanaged company pursuant to Florida Statutes Section 608.422.
