ARTICLES OF ORGANIZATION

OF

DEANE, LLC

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute §608, as amended, hereby sets forth the following:

ARTICLE I

Name

The name of the Limited Liability Company is, **DEANE, LLC**. (hereinafter referred to as the "Limited Liability Company")

ARTICLE II

Principal Office

The principal place of business and mailing address of this Limited Liability Company shall be **DEANE, LLC**, 1125 Hounds Run, Safety Harbor, Florida 34695

ARTICLE III

Duration

Written Operating Agreement

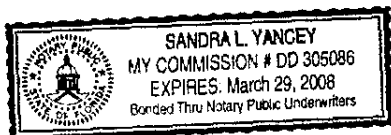


