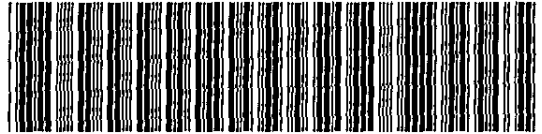

Additional members may be admitted by the Members in accordance with the terms and conditions of the Operating Agreement for this Company as the same may exist from time to time.


**ARTICLE SIX**
