

ARTICLES OF ORGANIZATION  
OF  
MANER PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be MANER PROPERTIES, LLC

ARTICLE II – ADDRESS

The mailing address of the principal office of the company shall be 13301 WATERFORD RUN DR, RIVERVIEW, FL 33569.

ARTICLE III – DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles.

ARTICLE IV – REGISTERED OFFICE AGENT

ARTICLE V – CAPITAL CONTRIBUTIONS

#### ARTICLE XI – MANAGEMENT




