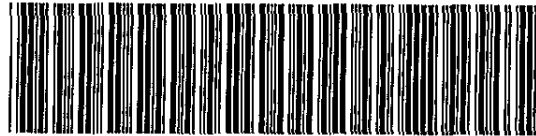

FIRST: The Articles of Organization were filed on 01/25/2005 and assigned document number 01.


SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:
