

- 3. The Articles of Organization of the Company are hereby amended to add a new Article 7 to read in its entirety as follows:

The interests of the Company are securities represented by certificates in registered form governed by Article 8 of the Florida Uniform Commercial Code and shall be treated as securities for all purposes under the Florida Uniform Commercial Code."
