**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, **EMR DALE MABRY, LLC** adopts these Articles of Amendment:

FIRST: The name of the limited liability company is EMR Dale Mabry, LLC (the "Company") and the assigned document number is L05000005259.

SECOND: The Articles of Organization were filed on January 18, 2005.

THIRD: Article V of the Company's Articles of Organization is amended in its entirety to read as follows:
