**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, **ANA DALE MABRY, LLC** adopts these Articles of Amendment:

FIRST: The name of the limited liability company is Ana Dale Mabry, LLC (the "Company") and the assigned document number is L05000005261.

SECOND: The Articles of Organization were filed on January 18, 2005.

THIRD: Article V of the Company's Articles of Organization is amended in its entirety to read as follows:

The Company is a manager managed company as described more fully in the operating agreement of the Company ("Operating Agreement"), and the business and affairs of the Company shall be managed by or under the direction of one or more managers (the "manager").
