The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **ORTIZ ROOFING LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 10003 Satellite Boulevard Suite 200, Orlando, Florida 32837 and the mailing address shall be 6419 Osprey Court, Woodbridge, Virginia 22193.

ARTICLE 3 - EFFECTIVE DATE




