I hereby consent to and endorse the actions and assertions contained in this instrument and disclaim any interest or ownership or other claim on this entity.

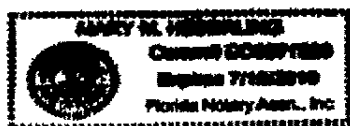


