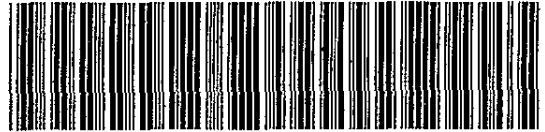






ARTICLE IV – MANAGEMENT
