



**ARTICLES OF ORGANIZATION**

**OF**

**DONWEL PROPERTIES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 (the "Act"), hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be DONWEL PROPERTIES, LLC (the "company").

**ARTICLE II -- ADDRESS**

The mailing address of the principal office of the company is Box 317, 12121 Little Road, Hudson, Florida 34667, and the street address is 12025 Boynton Lane, New Port Richey, Florida 34654.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

**ARTICLE IV -- PURPOSE**

The purpose for which the company is organized is to engage in any and all business or activities permitted under the Laws of the United States and the State of Florida. The company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

**ARTICLE VII -- ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the Operating Agreement.

**ARTICLE VIII -- ADMISSION OF NEW MEMBERS**

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Operating Agreement, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE IX -- MEMBERS' RIGHT TO CONTINUE BUSINESS

So long as the company continues to have at least one remaining member, the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member, or the occurrence of any other event that terminates the continued membership of any member, or any other event that, under the Act, would result in dissolution of the company, shall not cause the company to be dissolved, and the business of the company may be continued and the company will not be dissolved without the prior written consent of all the remaining members of the company.


ARTICLE X -- MANAGEMENT






