

ARTICLES OF ORGANIZATION

OF

NORTHSIDE CARDIOLOGY , PLLC

A, Professional Limited Liability Company

The undersigned, for the purpose of forming a professional limited liability company, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

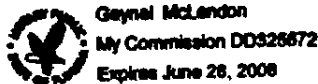
