Your referenced letter has been reviewed and I have had several subsequent telephone conversations with personnel in your office, regarding the matter.

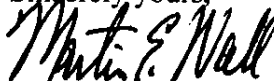
Accordingly, I now send you the following items:

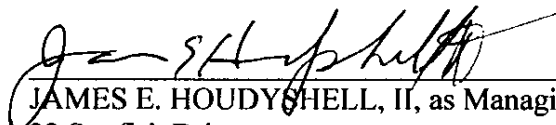

The name of the limited liability company is LINDA CAMBRIDGE, LLC."

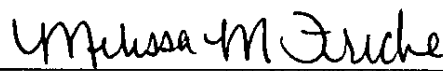

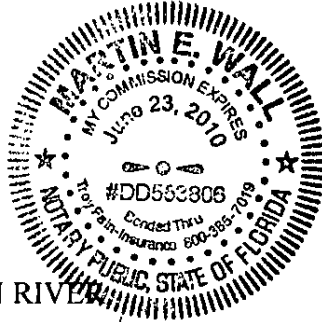
