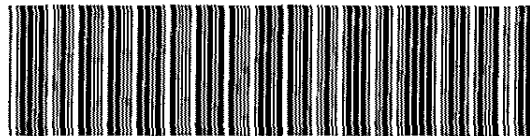


**ARTICLE IV — Members Rights to Continue Business:**
