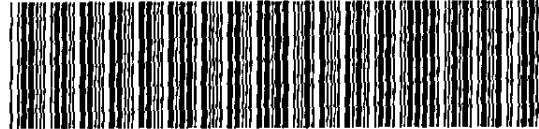

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SHIV HOSPITALITY LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 11736 US 19 State Road 52, Port Richey, Florida 34668 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

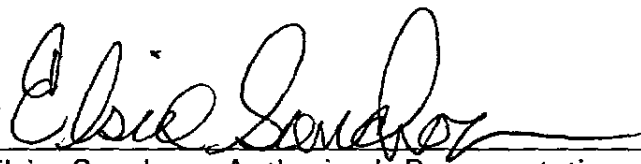
