ARTICLES OF ORGANIZATION OF OLD CORKSCREW PLANTATION V, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida SSEE, FLORI Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 -- NAME

The name of the limited liability company shall be OLD CORKSCREW PLANTATION V, LLC (the "Company").

ARTICLE II -- ADDRESS

A member may transfer its interest in the Company only as set forth in the Operating Agreement of the Company.

ARTICLE VI -- WITHDRAWAL OF MEMBERS

A member of the Company may withdraw from the Company only upon the unanimous prior consent of all the nonwithdrawing members of the Company.
