

ARTICLES OF ORGANIZATION OF MANATEE BAY, LLC

The undersigned, being authorized to execute and file these Articles, hereby certified

ARTICLE I — Name:

The name of the Limited Liability Company is: MANATEE BAY, LLC

ARTICLE II — Address:

The street address and mailing address of the principal office of the Limited Liability Company is: 789 South Federal Highway, Suite 310, Stuart, Florida 34994.

ARTICLE III - Duration:

The transfer by such trustee, receiver, executor, administrator, committee, guardian or conservator of any Company Interest shall be subject to all the restrictions to which such transfer would have been subject if such transfer had been made by such bankrupt, deceased, dissolved, liquidated, terminated or in competent Member.
