ARTICLES OF ORGANIZATION

OF

THE PAINTED IMAGE, LLC
A Florida Limited Liability Company

The undersigned, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

ARTICLE ONE – NAME

The name of the limited liability company shall be THE PAINTED IMAGE, LLC (the "Company").

ARTICLE TWO – COMMENCEMENT OF EXISTENCE

This Company shall commence existence on the date these Articles of Organization are accepted and filed with the Florida Department of State and shall continue until terminated in accordance with the Operating Agreement of the Company.

ARTICLE THREE – MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE

The mailing address and the street address of the principal office of the Company shall be 1174 Brandy Lake View Circle, Winter Garden, Florida 34787.

ARTICLE FOUR – INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the Company shall be located at 1174 Brandy Lake View Circle, Winter Garden, Florida 34787, and the initial registered agent of the Company at that address shall be TINA L. WILSON. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment to these Articles of Organization.

ARTICLE FIVE – PURPOSES AND GENERAL POWERS

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all the powers vested in a limited liability company organized and existing by virtue of such laws.

ARTICLE SIX – MANAGEMENT

The Company shall be a manager-managed company. The Company shall be managed by at least one (1) manager. The number of managers may be increased as provided in the Operating Agreement of the Company.

ARTICLE SEVEN – AMENDMENT

The Company reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment hereto, and any right conferred upon the Members is subject to this reservation, which amendment or repeal shall only be effectuated by the unanimous written approval of all Members of the Company or as otherwise provided in an Operating Agreement for the Company.

ARTICLE EIGHT – ADOPTION OF OPERATING AGREEMENT

The Company shall adopt an Operating Agreement for the Company, which may contain any provisions for the regulation and management of the business and affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608 of the Florida Statutes.

ARTICLE NINE – HEADINGS AND CAPTIONS

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force of effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
