TO THE
ARTICLES OF ORGANIZATION

The Articles of Organization of GAL LLC, a limited liability company formed on January 20, 2005, under the laws of the State of Florida (the "Company"), are hereby amended as follows:

1. Article V of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:

ARTICLE V
MANAGEMENT

The Company shall be manager-managed in accordance with the Operating Agreement. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law, this Instrument and the Florida Revised Limited Liability Company Act.

2. Article VI of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:

ARTICLE VI
RESTRICTIONS ON MEMBERSHIP

New Members shall only be admitted upon consent of the Members holding all of the Class A Membership Units, and otherwise in compliance with and agreeing to the terms and provisions of the Operating Agreement.


