# ARTICLES OF ORGANIZATION OF AFTER THE FLOOD LLC a Florida Limited Liability Company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

- 1. NAME. The name of the Limited Liability Company is AFTER THE FLOOD LLC (the "Company").
- 2. MADING AND STREET ADDRESS OF PRINCIPAL OFFICE. The mailing and street address of the principal office of the Company is: 10693 Wiles Road, Suite 184, Coral Springs, Florida 33076.
- 3. <u>PURPOSE</u>. The purpose of the Company is to be organized and operated to raise funds to be contributed toward relief efforts for those who suffered as a result of the Indian Ocean tsunami that devastated portions of south and east Asia on December 26, 2004.
- 4. <u>POWERS</u>. The Company shall have the power to acquire, own, maintain and use its assets for the purpose for which it is organized, to raise funds by any legal means for the encouragement of its purpose; to exercise all powers necessary or convenient to the furtherance of the purpose for which the Company is organized, and shall have such other powers as are granted to exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and not-for-profit organizations under the Florida Statutes; provided, however, that the Company shall not engage in activities or exercise any powers that are not in furtherance of the specific purpose of this Company.

#### 5. LIMITATIONS.

- A. No earnings of the Company shall inure in whole or in part to the benefit of private individuals or any members, except that reasonable compensation may be paid for services rendered to or for the Company affecting one or more of its purposes.
- B. No substantial part of the activities of the Company shall consist of carrying on propaganda, or otherwise attempting to influence legislation.
- C. Notwithstanding any other provisions of these Articles of Organization, the Company shall not conduct or carry on any activities not permitted to be

conducted or carried on by an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

- 6. <u>DISTERUTION ON SURPLUS ON LIQUIDATION</u>. Upon the liquidation, dissolution or other discontinuance of the charitable activities and operations of the Company, any surplus remaining after payment of the just debts and liabilities of the Company shall not be distributed to or among the members of the Company, but after making provision for the payment of all of the liabilities of the Company, the remaining assets shall be distributed to such other organization or organizations, as selected by the members, as are exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
- 7. INTERNAL REVENUE CODE. All references herein to the "Internal Revenue Code" shall refer to the Internal Revenue code of 1986, as amended, and the relevant Treasury Regulations thereunder, as they now exist or as they may hereafter be amended, or any corresponding provisions of any later federal tax laws.
- 8. <u>REGISTERED AGENT</u>. The name and address of the initial registered agent in the State of Florida, who se Consent to Appointment as Registered Agent accompanies these Articles of Organization. is: Janet Brockway, 10693 Wiles Road, Suite 184, Coral Springs, Florida 33076.
