ARTICLES OF ORGANIZATION OF

KOCH HOLDINGS, LLC

ARTICLE I Name and Address

The name of the limited liability company shall be **KOCH HOLDINGS**, **LLC**. The mailing and street address of the principal office of the limited liability company is: 4351 Bay Beach Lane, Unit 431, Fort Myers Beach, Florida 33931.

ARTICLE II Duration

This limited liability company shall be perpetual.

In the event of withdrawal, retirement, death, bankruptcy or expulsion of a member, the remaining members, of any, shall have the right to continue the business of this limited liability company, pursuant to the applicable provisions of the Operating Agreement and the regulations.

ARTICLE XIII Dissolution and Liquidation
