

**Operating Agreement.** The Operating Agreement of the Company shall be made, altered or rescinded by a majority vote of the members of the Company at a meeting of the members.


#### ARTICLE VII

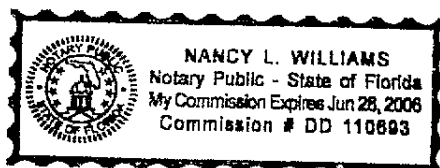


