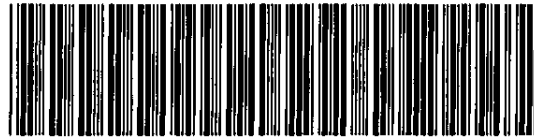

**SECOND:** This amendment is submitted to amend the following:


Article V of the Articles of Organization are hereby amended as follows:
