 - (d) Make contracts or guarantees or incur liabilities; borrow money at such rates of interest as the limited liability company may determine; issue its notes, bonds, or other obligations or

secure any of its obligations by mortgage or pledge of all or any part of its property, assets, franchises or income.

 - (k) Cease its activities and surrender this Certificate of Organization.
- (1) Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the limited liability company is organized.
- (m) Transact any lawful business which the Members find to be in aid of governments policy.
- (n) Pay pensions and establish pension plans, profit-sharing plans and other incentive plans for any or all of its employees.

- (o) Be a promoter, incorporator, general partner, limited partner, Member, associate, or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other enterprise.
 - (p) Have and exercise all other powers necessary or convenient to effect its purposes.

ARTICLE VI

Registered Office and Registered Agent
