FIRST: The Articles of Organization were filed on January 26, 2005 and assigned document number L05000007966.

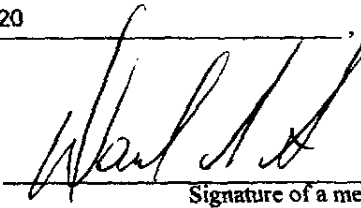
SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:
