**ARTICLES OF ORGANIZATION OF  
WINDERMERE CONCIERGE, LLC**

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a natural person over the age of 18 years, and being a member or an authorized representative of a member of WINDERMERE CONCIERGE, LLC, hereby forms a limited liability company.

**Article 1 (Name)**

The name of the limited liability company is WINDERMERE CONCIERGE, LLC

**Article 2 (Duration)**

The duration of the limited liability company shall be twenty five years from the date of filing of these Articles of Organization, which such period may, from time to time, be extended, by amendment to these Articles upon the unanimous vote of members.

**Article 3 (Initial Principal Office)**

The address of the initial principal office of the limited liability company shall be 9158 Phillips Grove Terrace, Orlando, Orange County, Florida 32836.

**Article 4 (Registered Office & Agent)**

The address of the initial registered office within the State of Florida for the limited liability company and the registered agent at that address is Kimberly M. Moore at 9158 Phillips Grove Terrace, Orlando, Florida 32836.

**Article 5 (Additional Members)**

No person may be admitted as a member of the limited liability company except upon the unanimous written consent of then existing members of the limited liability company.

**Article 6 (Continuation of Business Upon Termination of Member)**

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, upon unanimous written consent, the remaining members shall have the right to continue the business of the limited liability company.

**Article 7 (Management)**

The affairs of the limited liability company shall be managed by one or more managers who shall be elected by and hold such offices as may from time to time be

determined by a majority of the members of the limited liability company. The names and addresses of the initial managers of the limited liability company who shall serve until the first annual meeting or until their successors are duly elected and qualified shall be Kimberly M. Moore, whose address is 9158 Phillips Grove Terrace, Orlando, Florida 32836 and Amy B. DuRose, whose address is 3852 Winderlakes Drive, Orlando, Florida 32835.

#### Article 8 (Transferability of Member's Interest)

No member may assign, in whole or in part, his membership interest in the limited liability company without the unanimous written consent of the non-assigning members.

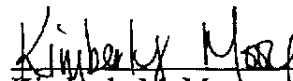
#### Article 9 (Initial Members)

The company shall have two members initially. The number of members may be increased or decreased from time to time by the Operating Agreement, but shall never be less than one member. #### Article 10 (Membership Classes)

The Operating Agreement of the company may provide for one or more classes of members, with or without voting rights, and having such other relative rights, powers, and duties as the Operating Agreement may from time to time provide.

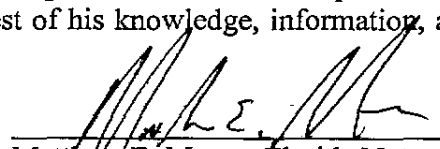

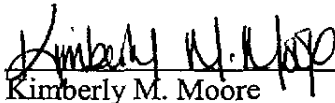
