ARTICLES OF ORGANIZATION OF WINDERMERE CONCIERGE, LLC

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a natural person over the age of 18 years, and being a member or an authorized representative member of WINDERMERE CONCIERGE, LLC, hereby forms a limited liability company.

Article 1 (Name)

Article 2 (Duration)
