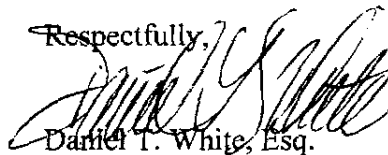

First, the Company's original *Articles of Organization* of record were filed by the undersigned and became effective on January 18, 2005, and have been assigned the document number L05000008709.

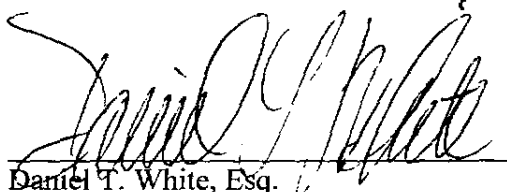
Second, the original *Certificate of Registered Agent* contained an erroneous statement taking the form of an inadvertent, incorrect reference to another entity.

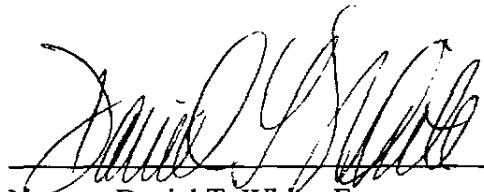

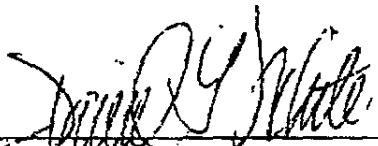

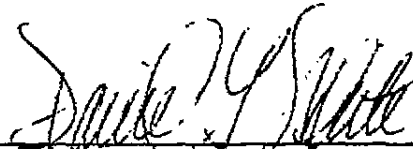
