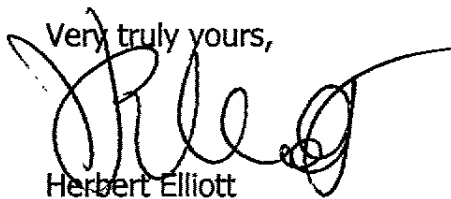

ARTICLES OF ORGANIZATION

ARTICLE I

Name

The name of the limited liability company (the **Company**) formed hereby is:

Address of Registered Office

Admission of Additional Members

Any New Member will be entitled to all of the same rights and privileges as the original Member. The terms of such admission and the capital contributions of any newly admitted members will be determined by the existing Members.

ARTICLE VII

Members Rights to Continue Business

In the event there is more than one Member, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, the surviving and/or remaining Member(s) shall have the right to continue the Company or to terminate and liquidate the Company.
